Public Guardian and Trustee of British Columbia announces stringent staff security clearance measures

Improvements made to hiring and internal controls enhance protection of client accounts

Vancouver – The Public Guardian and Trustee of British Columbia announced today that it has significantly improved its internal controls, policies and processes and implemented stronger security practices.

The improvements were made following a rigorous and extensive examination of the organization's internal systems and controls after the Public Guardian and Trustee and twelve of its clients were defrauded by former temporary employee Bryan Tickell in 2007. Tickell was sentenced today to a 6 year term of imprisonment for employment fraud, forgery and theft.

"We are grateful that the North Vancouver RCMP and Crown Counsel gave this very serious matter considerable attention and worked so diligently to bring some justice for those affected," said Jay Chalke, QC, Public Guardian and Trustee. "Now that the criminal proceeding has reached this result, we are moving forward and focusing our efforts on serving the British Columbians who have entrusted us with the management of their personal and financial affairs."

Many systems and controls improvements have been implemented over the past year which better protect the 32,110 clients under the Public Guardian and Trustee's care.

"Although the misappropriated funds have long since been returned to the client accounts they were wrongfully taken from, it was critical for us to make permanent improvements to our systems and controls that would protect our clients, their trust accounts and our organization from any future incidents," said Chalke. "I am confident that the improvements we have made and that we will continue to make to our security systems and policies will allow us to move forward, serving our clients."

The organization's recruiting standards have significantly been improved and all candidates must undergo an enhanced security clearance check which includes, but is

not limited to, the following:

- criminal record check
- police record check
- personal bankruptcy check
- Financial Institutions Commission check
- Securities Commission check
- various Justice System databases checks
- educational qualification verification
- employment history verification
- professional accreditation and disciplinary check

The improvements to hiring are in addition to several improvements that were made internally with respect to the systems and controls governing the handling of client assets, wills and disbursements. Further improvements are being implemented over the next year.

"We sought out, obtained and followed expert advice on how we could improve our controls. As with all financial institutions, this work is never done and I am committed to continuing this process as we move forward," said Chalke. "In the meantime, our enhanced security clearance requirements are among the most stringent of any public body in British Columbia."
